Contract Record FAQ

- **When do I create a contract record?**

If you have a contract, you need to create a record in EPC. The Form 471 requires you to associate a contract, unless you have a month-to-month or tariff agreement.

- **How many contract records do I create?**

One for each contract you have. If you are currently under a multi-year contract that was executed prior to EPC, you will still need to create a record in EPC in order to file a 471.

- **Can I delete a contract record?**

No, once you have submitted a contract record, it cannot be edited or deleted.

- **Where do I post any contract amendments?**

Once a contract record is submitted, it cannot be edited. Keep any contract amendments for your records but they cannot be added to your record in EPC.

- **Do I need to create a new contract record if I amend an existing contract?**

No, a new record is not needed. Keep all amendments/documentation in your files.
